Dear Mr. Secretary:

During hearings before the Manpower and Personnel Subcommittee of the Armed Services Committee, defense witnesses have described a significant change in the plans for deploying forces to NATO in the event of an emergency. These revised plans reflect a shortening of deployment time and an increase in both active and reserve manpower to be sent to Europe in the first 90 days of a contingency. I generally agree that we must be able to move our forces to Europe rapidly in the event of a Warsaw Pact attack.

I would appreciate your analysis of the following questions:

- (a) What types of active and reserve units in each Service and component would be deployed for each 10-day intervals for the first 90 days.
- (b) How many active, reserve and filler personnel would be deployed from each active and reserve component for the same time periods.
- (c) How does the readiness of active and reserve units today compare with this deployment plan.
- (d) What types of active reserve and civilian airlift and sealift would be used for each time period and how does the airlift and sealift capacity compare with the demands for movement.

Please relate the analysis of these deployment plans to the charts of the planned buildup in Europe already presented to the Subcommittee.
